4 Purpose

General Data Protection (GDPR), known as the global standard for protecting personal information, requires to establish an independent public authority to supervise the protection of personal information. Such supervisory authority must act independently in exercising its powers. Additionally, to ensure their independence, it is essential for the Commissioners of the Supervisory Authority to be free from any directions or any other external influence, whether direct or indirect, which could call into question the performance by those authorities of their task.

In Japan, the Personal Information Protection Commission (hereafter 'PPC') serves as this supervisory authority. It was established as an independent administrative commission with a high degree of independency under the provision that '[a] chairperson and commissioners of the Commission exercise their official authority independently' (Article 133 of the APPI), ensuring its independent powers.

However, the PPC's mandate goes beyond protecting personal information to include utilisation of personal information such as to extend the scope of providing My number. The PPC's powers largely differ from those provided under the GDPR in order to protect fundamental rights (human rights). In practical office, it raises questions whether the PPC is fulfilling its role in safeguarding personal information.

The Japan Federation of Bar Associations has expressed several opinions about protecting the rights and interests of the people including the protection of privacy in the process of the legal regimes of protecting personal information. They have also called for the strengthening the supervisory powers of the PPC and improving its structures and implementations.

Against this backdrop, this Symposium will examine from the perspectives of law such as constitutional law and public administration relating to the administrative structures as follows: What would be the structures toward an effective protection of personal information

and how would be structured and implemented to support the protection of personal information.
